#### 4. DELINQUENT WEEDS AND LITTER COLLECTION FEES

Report on the cost of abatement of weeds and litter and the hearing of any objections of property owners liable to be assessed for such abatement in accordance with the provisions of Chapter 8.28 of the Norwalk Municipal Code.

<u>Staff Recommendation</u>: That the Board direct staff to forward the listed properties to the City Council with a recommendation that the delinquent amounts be placed as a lien on the County Tax Roll unless the outstanding balance is paid prior to August 1, 2018.

Board's Action: Approved staff's recommendation by a vote of 3-0.

#### 5. EMERGENCY BOARD-UP COSTS

Report on the cost of emergency board-ups and the hearing of any objections of property owners liable to be assessed for such abatement in accordance with the provisions of Chapter 15.32 of the Norwalk Municipal Code.

<u>Staff Recommendation</u>: That the Board direct staff to forward the listed properties to the City Council with a recommendation that the delinquent amounts be placed as a lien on the County Tax Roll unless the outstanding balance is paid prior to August 1, 2018.

Board's Action: Tabled to allow staff to assess ordinance and noticing

requirements by a vote of 3-0.
