The City of Norwalk is in the process of preparing its 5-Year Consolidated Plan.

The plan is required by the Department of Housing and Urban Development for the use of Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) funds. The City anticipates receiving approximately \$6.1m in CDBG funds and \$1.5m in HOME funds over the next 5 years. The Consolidated Plan provides a strategy for addressing critical housing and community development needs of City residents.

Public input is critical to understanding community needs and setting funding priorities for housing, social services, and neighborhood improvements. Activities eligible for CDBG funding for low- and moderate-income families and neighborhoods include:

- Community services
- · Economic development assistance
- Improvements to public infrastructure and facilities
- Affordable housing
- Homelessness
- · Housing rehabilitation



Why is this important to you?

Public participation is a dynamic and ongoing process that is

essential to meeting the future needs of every community. The City must identify the housing and community development needs of the community to determine how to use these funds to achieve the most far-reaching public benefit. You are the public! When you make your voice heard, you are helping City leaders prioritize spending for you, your family, and your community.
