Indemnification and Hold Harmless

In consideration for the right to participate in the program, and to the fullest extent permitted by law, I, for myself, my heirs, executors, personal representatives, administrators, assigns, and next of kin, hereby indemnify and hold harmless the City, and its respective officials, officers, agents, volunteers and employees ("Indemnitees"), from and against any and all claims, demands, causes of action, costs, expenses, liabilities, losses, damages or injuries, in law or equity, to property or persons, including, without limitation, wrongful death, that arise out of, pertain to, or are incident to my participation in the program, whether arising from the active or passive negligence Indemnitees or otherwise.

Release

In consideration for the right to participate in the program, and to the fullest extent permitted by law, I, for myself, my heirs, executors, personal representatives, administrators, assigns, and next of kin hereby release, discharge, and agree not to sue the City, and its respective officials, officers, agents, volunteers, instructors, and employees, and other organizations participating or involved in providing or promoting classes, functions, programs, testing, or other activities that I participate in, the Angel Tree Project Event, and their respective including owners, officials, officers, directors, employees, agents, volunteers, and representatives (collectively, "Releases"), with respect to any and all injury, disability, death, loss or damage to person or property, demands, or liabilities, that arise out of, pertain to, or are incident to my participation in the program, whether arising from the active or passive negligence of Releases or otherwise.

I understand that I may be photographed or videotaped. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the City.
