SUBJECT: POLICY DIRECTION FOR THE 2020 CONSOLIDATED PLAN AND

FISCAL YEAR 2020/21 ANNUAL ACTION PLAN

Background:

The City receives Community Development Block Grant (CDBG) and HOME Investment Partnerships program (HOME) funds from the United States Department of Housing and Urban Development (HUD). As a recipient of these funds, the City is required to submit to HUD a Consolidated Plan and Analysis of Impediments to Fair Housing Choice every five years and an Annual Action Plan each year. The Consolidated Plan outlines the City's housing, infrastructure, economic development and social service needs and the programs and activities the City plans to carry out to address those needs. The Annual Action Plan details the specific activities that will be implemented during the fiscal year, the funds allocated to each activity, and the anticipated outcomes or accomplishments.

The Consolidated Plan submission must also include an Analysis of Impediments to Fair Housing Choice (AI). The AI focuses on actions, omissions and decisions made which restrict, or have the effect of restricting, housing choices or the availability of housing choices on the basis of race, color, religion, sex, disability, familial status or national origin in the City of Norwalk. Such actions may include lending decisions, real estate advertising, discrimination in rental housing, hate crimes and zoning requirements.

The City's next 5-year Consolidated Plan covers the period of July 1, 2020 through June 30, 2025 and the Annual Action Plan is for Fiscal Year (FY) 2020/21. Both plans must be submitted to HUD by May 15, 2020. A critical part of the Consolidated Plan process is the identification of needs through community participation. The findings from these community participation efforts are summarized in this report and detailed in the attachments. Before drafting the Consolidated Plan and Annual Action Plan and

releasing the annual social service agency funding applications, the community needs, priorities, and possible initiatives are being presented to City Council for policy direction.

Program Objectives and Eligible Uses

The primary objective of the CDBG program is the development of viable urban communities by providing decent housing, a suitable living environment and expanded economic opportunities for persons of low and moderate income. Under certain conditions an activity may qualify if it eliminates blighted conditions or alleviates an urgent need, such as conditions caused by a natural disaster. The HOME program objective is to increase the availability and accessibility of affordable housing for low income households. HUD requires that each activity funded with CDBG and HOME funds meet at least one of these Federal objectives.

The CDBG regulations dictate eligible uses and funding caps for certain activities. Some eligible uses of CDBG funding include:

Within the eligible uses above, there are additional restrictions on the nature of the activity and who the activity benefits. For example, a property acquisition using CDBG funds would be eligible if the property will be used for a public facility serving low to moderate income residents. However, a property acquired for a commercial use that will not create jobs for low-income residents would not be an eligible use of CDBG funds. Generally, most activities must either directly benefit a person of low to moderate income or be located in a low to moderate income area (see Attachment 1 for CDBG eligible areas).

- Affordable rental housing (Community Housing Development Organization)
- Fair housing program
- Program Administration

Consolidated Plan Needs Assessment

As a part of the Consolidated Plan and Analysis of Impediments, the City is required to assess community needs and seek participation from residents, community organizations, and other stakeholders. Staff held three (3) community meetings concerning the proposed plans and conducted a survey. Additionally, City Council members were interviewed about the community needs. Summaries of the survey, community meetings, and City Council interviews are provided in Attachments 2 – 5.

The community needs survey requested that the respondent rate 42 services as "extremely important" to "least important" based on what the respondent felt was the level of need. The programs and activities are in the categories of housing, infrastructure, homeless services, economic development, community services, community facilities, and services for special needs. The City received 879 survey responses. A detailed summary of the community needs survey results are provided in Attachment 2.

Based upon the survey results, meetings, and interviews, the following community needs have emerged:

- Affordable rental housing for families, seniors, and disabled and homeownership opportunities
- Infrastructure improvements: Streets, safe routes to school, lighting, and graffiti removal
- Public facilities: Parks, youth centers, and community centers
- Homeless prevention
- Community services
- Assistance with home improvements

• Economic Development: Attract job generating businesses Consolidated Plan Priorities and Activities

Staff estimates that it will receive approximately \$6.1 million in CDBG funds and \$1.6 million in HOME funds over the next five years. The City's CDBG and HOME funds are not enough to address all of the City's housing, infrastructure, economic development and social service needs. Therefore, the City must prioritize needs and determine the types of activities to be funded. Based upon the needs assessment, staff recommends the following priorities and activities for the 2020-2025 Consolidated Plan:

Community Fund: Social service agencies

On December 4, 2018, the City Council directed staff to prioritize homeless services for funding under the social service agency funding application process. Additionally, staff was to develop methods to evaluate program outcomes and identify fewer programs to receive larger grants. Three (3) agencies are being funded in the FY 2019/20, which was a reduction from eight (8) previously funded agencies.

The above programs started July 1, 2019. Therefore, only three (3) months of data about the programs is available. The data is summarized in Attachment 6. Because the programs and data collection requirements are new, it is too soon to evaluate their effectiveness. Based upon the results of the community needs assessment, staff recommends that the City continue to prioritize programs serving residents who are homeless or at risk for homelessness. The above organizations would be required to reapply and compete for funding for next fiscal year. Staff plans to issue the application for social services funding on November 22, 2019.

Background:

A presentation was given to City Council on November 19, 2019 providing information regarding outreach and data collection efforts required for both the Analysis of Impediments to Fair Housing Choice and the Consolidated Plan. City Council requested staff to further discuss direction and comments provided regarding recipients of the 2020-2021 Community Development Block Grant (CDBG) funds (see Attachment) and provide the information to City Council at a meeting prior to the public hearing to adopt the plan. Additionally, City Council indicated the plan should be provided well in advance of the public hearing as a study session.

The purpose of this study session is to inform and receive input from City Council regarding the 2020 Consolidated Plan and Fiscal Year (FY) 2020/21 Annual Action Plan. City staff are seeking to obtain City Council authorization for public review of the Consolidated Plan and approval of the FY 2020/21 project work. The United States Department of Housing and Urban Development (HUD) requires CDBG and HOME Investment Partnerships (HOME) funding recipients to submit a Consolidated Plan every five years and an Annual Action Plan each subsequent year. The FY 2020/21 Annual Action Plan lists the activities that the City will undertake with HUD in Year 1 of the Consolidated Plan. These activities are subject to federal rules and regulations, such as funding caps, public-private partnerships, requirements, and compliance with national objectives.

Community Engagement

A community engagement program was undertaken including engagement notifications, promotional flyers, email blasts, and multiple meeting reminders to residents, partners, social services and City staff:

- Stakeholder One-On-One Interviews (15)
- Community Needs Survey (879 respondents)
- Housing Summit (6 speakers; 57 attendees)
- Public Meetings (2)
- Public Hearing (1)

Stakeholder concerns included:

- Economic well-being, self-sufficiency and resiliency
- Housing needs and affordability
- Special population needs
- Smart decision-making funds being spent on highest needs, spending on activities having the highest community benefit
- Attaining shared goals

Community Needs Survey Summary

The following information is a summary of the results from the Community Needs Survey. Additional information may be found in the Appendix of the 2020 Consolidated Plan.

- Top Housing Needs:
 - 63% of Spanish-speaking respondents and 50% of English-speaking respondents indicated senior housing as a priority
 - 58% of all respondents identified affordable rental housing as a priority
 - 63% of Spanish-speaking respondents indicated housing for disabled persons as a priority
- Top Affordability Needs:
 - o 58% of all respondents indicated affordable rental housing as a priority
 - Jobs and housing make up a secondary theme and seen as a solution to affordability
- Top Facilities and Neighborhood Improvements Needs:
 - 55% of Spanish-speaking respondents and 60% of English-speaking respondents identified youth centers as a priority
 - 47% of Spanish-speaking respondents and 60% of English-speaking respondents identified parks and recreational facilities as a priority
 - o 67% of all respondents identified safe routes to school as a priority
 - Neighborhood crime prevention programs was also identified as a coinciding theme and need

Funding and Proposed Activities

The City anticipates receiving \$1,270,803 in CDBG entitlement funds and \$288,000 in carryover funds and \$345,459 in HOME entitlement funds and \$239,388 in HOME carryover funds from HUD. The Consolidated Plan explains how the City will utilize these monies to improve community development needs, address affordable housing, and priorities for people experiencing homelessness. The Annual Action Plan (AAP) establishes strategies for the next program year and identifies specific projects and activities that will be undertaken with CDBG and HOME funds received from HUD.

The City received eight (8) applications for funding. 


Survey results: What types of housing are most needed?








- Community Development Block Grant (CDBG)
 Program authorized under Title I of the Housing & Community Development Act of 1974.
- Department of Housing and Urban Development (HUD) gives the City of Norwalk Entitlement Grants under CDBG
- To receive these funds, the City must complete and submit to HUD a Consolidated Plan Document (CPD).





What is a Consolidated Plan?

- The CPD covers a five-year period.
- The Consolidated Plan (ConPlan) is designed to aid the City in assessing affordable housing and community development needs
- The ConPlan determines how funds from the U.S. Department of Housing and Urban Development (HUD) are used
- Priorities are determined through data analysis as well as a communitywide outreach program.
