*The City of Norwalk Utility User's Tax as adopted by the Norwalk City Council applies only to the following utilities: Electric, Gas, Telephone, Long Distance Carrier and Cellular Phone Service.

Senior Utility Users Tax Exemption

Senior Citizens who meet the following criteria will receive a 100% exemption from the City of Norwalk's Utility User's Tax. The City of Norwalk collects Utility User Tax (UUT) on electric, gas and telecommunication services at a rate of 5.5%.

To be eligible:

1. The Applicant or Spouse must be 65 years or older and must reside at the service address.
2. The Applicant must provide proof of age. (A legible photocopy of your birth certificate, valid CA driver's license, CA State ID, or similar government issued identification is required.)
3. The Applicant must fill out, sign, and return the application along with recent copies of the utility bill(s) for which they are applying for an exemption. The bill(s) provided have to be under the name of the applicant.

***Please note: The exemption goes into effect 30-60 days after the application is submitted to the City. (This is a utility company requirement.)**
