Trespass Arrest Authorization:

I request and authorize the Norwalk Sheriff/Norwalk Public Safety Department to enter the above property and to advice any persons, who are not exempted under N.M.C. Section 9.08.080, as follows:

Open to General Public-

To leave the premises and not return for twenty-four (24) hours, and to further advice that if he/she returns to the property within twenty-four (24) hours of advisement, he/she will be subject to arrest for trespassing. I further authorize the Norwalk Sheriff/Norwalk Public Safety Department to arrest anyone who has been so notified and refuses to leave or returns within twenty-four (24) hours for a violation of N.M.C. 9.08.050.

Not Open to General Public-

To leave the premises and not return for Twelve (12) months, and to arrest anyone who has been so notified and refuses to leave or returns within Twelve (12) months for a violation of N.M.C. 9.08.030.

In addition, I understand that my property must have signs posted in accordance with N.M.C.

9.08.020, and that the signs must state the following: "THIS PROPERTY CLOSED TO THE PUBLIC. No entry without permission. Norwalk Municipal Code Section 9.08.10"

My authorized agent will cooperate fully in the prosecution of anyone who is arrested for a violation of any local or state law, including trespassing or vandalism.

Skateboarding Ordinance Enforcement:

I request and authorize the Norwalk Sheriff/Norwalk Public Safety Department to respond to complaints of violations, act on observation of violations, and issue citations to persons found in violation of the skateboarding ordinance per Norwalk Municipal Code section 9.28.010. I also understand that prior to commencing any enforcement on the property, signs must be properly posted prohibiting the use of skateboards on the property in accordance with N.M.C. 9.28.050.

My authorized agent will cooperate fully in the prosecution of anyone who is arrested for a violation of any local or state law, including trespassing or vandalism.

Parking Enforcement Private Property:

I request and authorize the Norwalk Sheriff/Norwalk Public Safety Department to enter the above property during normal business hours for the purpose of enforcing all parking regulations related to this property. I understand that prior to commencing any parking enforcement on the property, signs must be properly posted providing notice of noted parking enforcement in accordance with N.M.C. 10.08.180. In addition, both the fire lanes (22500.1 CVC) and handicapped parking stalls (22507.8 CVC) must be properly painted and signed at the property entrances posted as per California Vehicle Code requirements.

My authorized agent will cooperate fully in the prosecution of anyone who is arrested for a violation of any local or state law, including trespassing or vandalism.
