Procedure for Filing a Title VI Complaint

The complaint procedures apply to the beneficiaries of City of Norwalk, Norwalk Transit System's (NTS) programs, activities, and services.

RIGHT TO FILE A COMPLAINT: Any person who believes they have been discriminated against on the basis of race, color, or national origin by NTS may file a Title VI com-plaint by completing and submitting the agency's Title VI Complaint Form. Title VI complaints must be received in writing within 180 days of the alleged discriminatory complaint.

HOW TO FILE A COMPLAINT: Information on how to file a Title VI complaint is posted on our agency's website, and in public areas of our agency.
