Purpose. Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

B.2	<p>New Activities.</p> <p>The Housing Authority will continue to administer up to 40 project-based vouchers at Soroptimist Village, which are under contract through June 30, 2027 and may dedicate up to 100 additional vouchers to other units under the project-based voucher program. Projects will be located in census tracts with poverty rates under the City's current poverty rate or in/adjacent to the City's economic opportunity nodes. The City of Norwalk has aging housing stock, high rents, and limited rental housing choices. As such, project-based vouchers are an appropriate option to facilitate the development of new rental housing or projects that create new housing opportunities for special needs populations, particularly for the homeless or individuals with disabilities. Additionally, project-based vouchers are a tool for preserving affordable housing that is at risk of converting to market-rate housing and for meeting program utilization goals in a tight rental market. Project-basing vouchers is consistent with the 5-year PHA Plan as it is one of the strategies listed in the Plan to address housing needs by utilizing project-based vouchers to increase the supply of assisted housing and supports the PHA Plan goal of maximizing leasing and budget utilization.</p>				

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in its 5-Year PHA Plan.</p> <p>Goal #1: Apply for additional rental vouchers should funding become available. Progress: There have been no opportunities to apply for new regular tenant-based vouchers. The authority will continue to seek for opportunities as they become available. However, in May 2021, the NHA did receive 46 Emergency Housing Vouchers (EHV’s) funding as authorized by the American Rescue Plan Act of 2021 and in September 2022, the NHA received an additional 7 Fair Share vouchers under the Consolidated Appropriations Act 2022.</p> <p>Goal #2: Maintain high performing status. Progress: The Housing Authority received high performer designation for its performance in FY 2015/16, 2016/17 & 2017/18. The NHA has applied for a SEMAP waiver (Notice PIH 2021-34) which waives the application of SEMAP in its entirety.</p> <p>Goal #3: Maximize leasing and budget utilization. Progress: The Authority is experiencing a shortage of available units in the City of Norwalk due to the eviction moratorium. Participants are struggling to find units to lease-up. The Authority staff called every single property owner that listed with our Business Licensing Department to promote our program and to see if we could match vacancies with voucher holders. The Authority followed up by mailing flyers and advertising in the Norwalk Patriot and on all social media platforms. In addition, the Authority is purging its waitlist and extending the term of the vouchers. To summarize our utilization rate has dropped. The Authority is planning to organize a mass waitlist pull and lease-up as soon as the COVID surge is under control. Lastly, the Authority is working on increasing its payment standards to a 110% of the HUD published fair market rents to be able to compete with the current high market rents. The Authority is hoping that it will be able to maximize its leasing with all these efforts.</p> <p>Goal #4: Promote economic self-sufficiency among program participants. Progress: The Authority continues to administer the Family Self Sufficiency (FSS) program with 13 slots. The Authority received FSS Grant funding for the past five years. The Authority strengthened its partnership with the Southeast Los Angeles County Workforce Development Board by approving a new Memorandum of Understanding (MOU) on August 15, 2017 and updated MOU on April 17, 2022. The Authority continues to maintain partnerships with Cerritos College and the Norwalk-La Mirada Unified School District. Information about job opportunities, training, job fairs, and scholarships are shared with FSS participants throughout the year. The Authority also serves on the System Management Team for the local America’s Job Center of California (AJCC).</p> <p>Goal #5: Undertake affirmative measures to provide a suitable living environment for families living in assisted housing, regardless of race, color, religion, sex, familiar status, and disability. Progress: The program is promoted to all segments of the Norwalk population. Housing Quality Standards are applied equally to all units regardless of location or family type. The Authority provides more housing search time to disabled households and reviews reasonable accommodation requests on a case-by-case basis. The Authority works closely with the Fair Housing Foundation to assist participants with fair housing issues and to provide fair housing training to landlords. The Housing Authority also participated in the development of the City’s 2015 and 2020 Analysis of Impediments to Fair Housing Choice.</p>
