Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

B.2	<p>New Activities.</p> <p>The NHA will continue to administer up to 40 project-based vouchers at Soroptimist Village, which are under contract through June 30, 2027. Soroptimist Village located at 12657 Foster Road, Norwalk has requested 5 additional project-based vouchers for units that were destroyed in a fire in 2017. Insurance proceeds were awarded to Soroptimist Village to rebuild the units. The NHA will consider the request as soon as the units are completed, and a Certificate of Occupancy is issued which is anticipated in 2024.</p> <p>A new request for project-based vouchers was received from the Weingart Foundation during the reporting period for 54 project-based vouchers for a Homekey project that involves the conversion of a Motel 6 to house homeless individuals. The project is located at 10646 Rosecrans Avenue, Norwalk. The application is under consideration by Housing Authority staff. Subject to NHA approval, the units will be ready for move-in, November 2024.</p> <p>Primestor Development LLC also made a request during the reporting period for The Walk Residences project for 32 project-based vouchers for affordable multifamily rental housing to be located at 12700 Norwalk Blvd., Norwalk. The project proposes to leverage the tax credits with project-based vouchers.</p> <p>The Norwalk Housing Authority may also dedicate up to 100 additional vouchers to other units under the project-based voucher program. Projects will be in census tracts with poverty rates under the City's current poverty rate or in/adjacent to the City's economic opportunity nodes. The City of Norwalk has an aging housing stock, high rents, and limited rental housing choices. As such, project-based vouchers are an appropriate option to encourage and facilitate the development of new rental housing or projects that create new housing opportunities for special needs populations, particularly for the homes or individuals with disabilities. Additionally, project-based vouchers are a tool for preserving affordable housing that is at risk of converting to market-rate housing and for meeting program utilization goals in a tight rental market. The project-based voucher program is consistent with the 5-year PHA Plan as it is one of the strategies listed in the Plan to address housing needs by utilizing project-based vouchers to increase the supply of assisted housing and support the PHA Plan goal of maximizing leasing and budget utilization.</p>				

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in its 5-Year PHA Plan.</p> <p>During the 2020-2025 5-Year PHA Plan period, the following progress was made:</p> <p>Goal #1: Apply for additional rental vouchers should funding become available. Progress: The NHA has 54 additional project-based vouchers specifically for a Homekey Project under consideration.</p> <p>Goal #2: Maintain high performing status Progress: The Housing Authority received an overall performance rating of High for its SEMAP performance in FY 2022/23. To address deficiencies to SEMAP Indicator #7 <i>Expand Housing Opportunities</i>, the NHA will expand its outreach efforts by advertising the solicitation of landlords for the Housing Choice Voucher program through the Norwalk Now newsletter and will be conducting extensive and targeted outreach efforts through community events and workshops.</p> <p>Goal #3: Maximize leasing and budget utilization Progress: The Authority is experiencing a shortage of available units in the City of Norwalk due to limited inventory. As indicated in Goal #2, the NHA will address this deficiency by bolstering its outreach efforts to solicit landlords for the Housing Choice Voucher program.</p> <p>Goal #4: Promote economic self-sufficiency among program participants. Progress: The NHA continues to administer the Family Self Sufficiency (FSS) and has received FSS Grant funding for the past five years. Currently, the program has no mandatory slots and with only 4 participants, the FSS program is operating in a voluntary basis. The NHA held and Orientation event in September 2023 to recruit additional participants to the program. The NHA has also updated its marketing material for the program to solicit interest in the program.</p> <p>Goal #5: Undertake affirmative measures to provide a suitable living environment for families living in assisted housing, regardless of race, color, religion, sex, familial status and disability. Progress: The program is promoted to all segments of the Norwalk population. Housing Quality Standards are applied equally to all units regardless of location or family type. The NHA provides additional housing search assistance to disabled households and reviews reasonable accommodation requests on a case-by-case basis. The Authority works closely with the Fair Housing Foundation to assist participants with fair housing issues and to provide fair housing training to landlords.</p>
