\*The City of Norwalk Utility User's Tax as adopted by the Norwalk City Council applies only to the following utilities: Electric, Gas, Telephone, Long Distance Carrier and Cellular Phone Service.

## Utility User's Tax Exemption Criteria

1. The Applicant or Spouse must be 65 years or older. (The Applicant is the person in whose name the account is held.
2. The Applicant must reside at the service address.
3. The Applicant must fill out and sign the application.
4. The Applicant must show proof of age in person. (If housebound, the City will make other arrangements.)
5. Please bring with you, if possible, a recent copy of the utility bill(s) for which you are applying for an exemption.
6. The exemption goes into effect 30 to 60 days after the application is submitted to the City. (This is a utility company requirement)
7. Applications may be submitted at any of the following locations:
  - Norwalk Senior Center – 14040 San Antonio Boulevard
  - Alondra Social Services Center – 11929 Alondra Boulevard
  - Norwalk Housing Authority – 12035 Firestone Boulevard
  - Finance Department – Norwalk City Hall, 12700 Norwalk Boulevard, Room 6
