

## Eligible Taxpayers May File Tax Returns Free Online



The Board of Equalization now offers eligible taxpayers free electronic filing or "BOE-File" service for their Sales and Use tax returns. BOE-File is a process that makes it possible for taxpayers to use the Internet to file a California Sales and Use tax return and make a payment directly to the Board of Equalization. The return and payment are filed electronically eliminating postage cost and the possibility of items being lost or delayed in the mail.

Single-outlet retail taxpayer accounts, including temporary accounts, governmental agency accounts, and revoked accounts, are eligible. The Sales and Use tax return forms that may be electronically filed are BOE-401-EZ and BOE-401-A with Schedule A and T only. Taxpayers who are required to remit payment via Electronic Fund Transfer (EFT) are not currently eligible.

Taxpayers who do not want to use BOE-File but want to file electronically may use an authorized service provider that have successfully completed BOE acceptance testing. If a service provider is used, returns and payment information are electronically submitted to the authorized service provider who then transmits the information to BOE for processing. A fee may be charged for the service.

## County Announces Rate Increase at Local Landfills



The rate for trash disposal at the local landfills has increased once again in 2006 as part of a three-year series of rate increases approved by the County Sanitation Districts in 2004. These increases facilitate funding for various

Sanitation Districts' Solid Waste Management Facilities and the impending waste-by-rail disposal system (or remote disposal) anticipated for 2013 when the Puente Hills Landfill closes. The incremental increases in landfill charges are intended to smooth the transition to the full cost of remote disposal. Given this, effective January 2006, customers will see a 2.4 percent increase in their trash disposal rates.

Please note that the City has no authority over this rate increase and the trash companies do not profit from it, as the fees collected are a direct cost to dispose the waste at the landfill. Please contact Norwalk City Hall at (562) 929-5915 for questions related to the rate increase.
